O. Riddle in May, 1953, and being the revisions and additions on the revised plat of May, 1959, of record in the R. M. C. Office for Greenville County in Plat Book QQ at Pages 76-77, the streets herein conveyed having a minimum width of 50 feet and being designated on said plat as Fairfield Drive, Paxton Avenue, Rowan Street, Banner Street and Drury Lane.

This conveyance is made for street and roadway use and for inclusion in the Greenville County road system.
