Vaughn and his heirs and assigns forever:

All of those parcels or lots of land in Chick Springs Township of Greenville County, South Carolina, located about three miles northwest of the City of Greer, lying on the west side of a new street about 400 feet from State Highway No. 415, being shown and designated as Lots Nos. 32 and 33 on Plat No. 3 of the property of P.O. Copeland Estate, prepared by H.S. Brockman, Surveyor, dated August 6, 1958, and having the following courses and distances, to-wit:
