to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Edgar W. Teasley, his heirs and assigns,

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lots 47 and 48, on Plat of Magnolia Acres, plat of which is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book GG, page 133, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Cool Brook Drive, joint front corner Lots 47 and 48; and running thence N. 47-40 E. 158.2 feet to an iron pin, joint rear corner Lots 47 and 48; thence along the line of Lot 49 N. 83-33 E. 25.3 feet to an iron pin; thence along the rear line of Lot 45 S. 00-15 W. 101.7 feet to an iron pin; thence along the line of Lot 46 S. 33-35 W. 98.1 feet to an iron pin on Cool Brook Drive, joint front corner Lots 46 and 47; thence along Cool Brook Drive N. 49-50 W. 115 feet to an iron pin, the point of beginning.

BEGINNING at an iron pin on the easterly side of Cool Brook Drive, joint front corner Lots 47 and 48; and running thence N. 47-40 E. 158.2 feet to an iron pin; thence N. 75-33 W. 175 feet to an iron pin on Cool Brook Drive; thence around the curve of Cool Brook Drive as follows: S. 2-49 E. 84.5 feet, S. 35-03 E. 74.9 feet and S. 49-50 E. 7 feet to an iron pin, the point of beginning.

This deed is given for the purpose of correcting the line as to course and distance running between Lots 47 and 48. For prior deeds see Deeds Volume 630, page 253 and 633, page 53.
