Know All Men by These Presents:

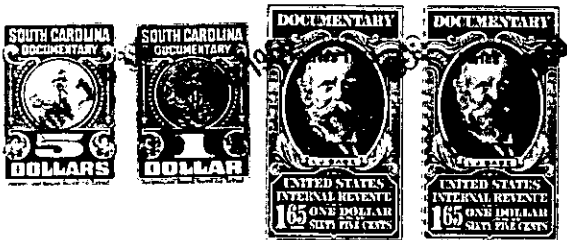
That I, O. C. Davis in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Warren Thomas Barksdale, his heirs and assigns

ALL that piece, parcel or lot of land in Gantt Township, County of Greenville, State of South Carolina, on South Carolina Highway 291 and being designated as Lot No. 4 of the O. C. Davis property as shown on a plat of said property by C. O. Riddle, R. I. S., dated October 2, 1958 and having according to said plat the following courses and distances, to wit:

BEGINNING at an iron pin on the South side of South Carolina Highway 291 at the joint front corner of Lots 3 and 4 and running thence along the line of Lots 3 and 4 S. 8 - 07 E. 396 feet to a pin; thence N. 81 - 53 E. 110 feet to a pin; thence N. 8 - 07 W. 396 feet to a pin on South Carolina Highway 291; thence S. 81 - 53 W. 110 feet along said South Carolina Highway 291 to the point of beginning.

BEING a portion of the property conveyed to the grantor herein by Otis Davis, et. al. by deed dated April 18, 1944 and recorded in Deed Volume 264 at page 83 in the Office of the R. M. C. for Greenville County.
