TITLE TO REAL ESTATE

COUNTY OF GREENVILLE

WHEREAS Elijah R. Ridgeway, Sr. died testate April 27, 1923 according to File 35, Apt. 180, Probate Court for Greenville County. He devised his property to his wife, Lucinda McCuen Ridgeway, for life. She died intestate May 23, 1919 (per affidavit). Next, he devised his property to his daughter, Ellen Ridgeway, for life or maidenhood, and at her death, if she remained unmarried and survived her mother, Lucinda Ridgeway, then the Executors were to sell and divide among the remaining seven children and one grandchild. Ellen Ridgeway died, unmarried, intestate July 6, 1959 (per affidavit). The eight children are as follows:
