KNOW ALL MEN BY THESE PRESENTS That WILKINS NORWOOD & COMPANY, INC. a corporation chartered under the laws of the State of South Carolina, and having its principal place of business at

Greenville in the State of South Carolina, for and in consideration of the sum of Two Thousand and No/100ths (\$2,000.00) dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto G. T. SIMPSON:

All that parcel or lot of land lying and being in the County of Greenville, State of South Carolina, being designated as Lot No. 61 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R.L.S., in January, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Roberta Drive at the joint front corner of Lots Nos. 60 and 61, and running thence with the line of Lot No. 60 S. 15-58 W. 210.9 feet to an iron pin in the subdivision property line; thence with the said subdivision property line N. 73-45 W. 110 feet to an iron pin at the joint rear corner of Lots Nos. 61 and 62; thence with the line of Lot No. 62 N. 15-58 E. 210.3 feet to an iron pin on the Southern side of Roberta Drive; thence with the Southern side of Roberta Drive S. 74-02 E. 110 feet to the point of beginning.

The foregoing lot is a portion of that conveyed to Wilkins Norwood & Company, Inc. by deed of Lucile L. Smith, et al, dated September 15, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 634 at page 188.

The foregoing lot is subject to a drainage easement 5 feet in width at the rear of said lot, and 5 feet in width on each side of the center line of a branch, which crosses the Northeastern corner of said lot.



Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging or in anywise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, his successors, heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and his successors, heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

on this the 10th day of November in the year of our Lord one thousand, nine hundred and fifty-nine and in the one hundred and eighty-fourth year of the Sovereignty and Independence of the United States of America.
