All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 3 on plat of Western Hills, plat of which is recorded in the R.M.C. Office for Greenville County in Flat Book QQ at Pages 98-9, and, according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on El Paso Drive, at joint front of Lots Nos. 3 and 4, and running thence with the line of said lots, N. 12-21 W., 150.5 feet; thence N. 85-52 E., 92.6 feet; thence S. 13-10 E., 150.9 feet to a point on El Paso Drive; thence with El Paso Drive, S. 86-26 W., 83.8 feet to the point of beginning.
