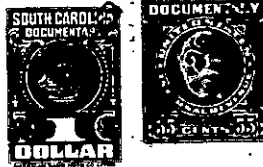

edged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s)

D. B. Brown, his Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, about three miles northwest of Greer, S. C., lying west of State Highway No. 415, and lying on the west side of an existing dirt Road, being shown as Lot No. 3 on Plat No. 3 of the P. O. Cope-land Estate made by H. S. Brockman, Surveyor, August 6th 1958, and being one of the same lots conveyed to me by deed recorded in the office of the R. M. C. for Greenville County in Deed Book 613 at page 177, and having the following courses and distances, to wit:-

Beginning on a stake on the western side of the existing dirt road and being the joint corner of Lots Nos. 4 and 3, and runs with the western margin of the said road, N. 17-50 E. 95 feet to a stake at the intersection of a new cut road; thence with the southern side of the new cut road, N. 72-10 W. 175 feet to a stake, joint corner of Lots Nos. 3 and 27; thence with the common rear line of Lots Nos. 3 and 27, S. 17-50 W. 95 feet to a stake, joint corner of Lots Nos. 26, 27, 4 and 3; thence with the common line of Lots Nos. 3 and 4, S. 72-10 E. 175 feet to the beginning corner.
