Know All Men by These Presents:

and assumption of mortgage described below,
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James E. Wyatt, his heirs and assigns,

All that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as a part of Lot 12 and a part of Lot 13 as shown on Plat of Property of G. L. Walker which plat is recorded in the RMC Office for Greenville County, S. C., in Plat Book H, pages 17 and 18; and having, according to said plat, and according to a plat of the Property of Cecil E. Merritt, made June, 1959, by R. W. Dalton, Engineer, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Rice Street (formerly Henrietta Avenue) which iron pin is 60 feet in an easterly direction from the intersection of Tyler Street and Rice Street; and running thence S. 26-48 E. 200.2 feet to an iron pin; thence N. 62-34 E. 60 feet to an iron pin; thence N. 26-56 W. 207 feet to an iron pin on Rice Street; thence along Rice Street S. 56-12 W. 60 feet to an iron pin, the point of beginning.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to C. Douglas Wilson & Co., said mortgage being recorded in Mortgages Volume 794, page 215.

This is the same property conveyed by deed recorded in Deed Book 628, page 382.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
