That Mary B. Kearse in consideration of the sum of Two Hundred and NO/100ths in the State aforesaid, DOLLARS,

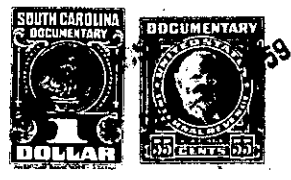
