to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

ALVIN A. McCALL, JR., His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as the front part of Lot Number 10 of a subdivision known as McSwain Gardens, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Page 75, and having the following metes and bounds, to wit:

BEGINNING at a point on the Eastern side of Shannon Drive at the joint front corner of Lots 9 and 10 and running thence S 84-30 E 172 feet to a point in the joint side line of Lots 9 and 10; thence S 06-05 W 84.7 feet to a point in the joint side line of Lots 10 and 11; thence S.86-37 W 156.5 feet to a point on the Eastern side of Shannon Drive at the joint front corner of Lots 10 and 11; thence with the Eastern side of Shannon Drive N 03-00 W 110 feet to the point of beginning.
