Mundy in the State aforesaid, in consideration of the sum of Two Thousand Three Hundred Forty Five and No/100----- DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. Lewis Stover, his heirs and assigns,

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 32, according to Plat of Section I of Lake Forest, which plat is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book GG, page 17, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Shenandoah Drive, joint front corner Lots 31 and 32; and running thence N. 32-32 W. 154 feet to an iron pin, joint rear corner Lots 31 and 32; thence along the line of Lot 24 N. 47-53 E. 105.7 feet to an iron pin on Stonewall Lane; thence along the curve of the intersection of Stonewall Lane and Shannon Drive, the chord of which is S. 50-43 E. 53.2 feet to a point on Shannon Drive; thence along Shannon Drive S. 29-31 E. 100 feet to an iron pin; thence around the curve of the intersection of Shannon Drive and Shenandoah Drive, the chord of which is S. 14-55 W. 35.7 feet to an iron pin on Shenandoah Drive; thence along Shenandoah Drive S. 59-20 W. 89.4 feet to an iron pin, the point of beginning.

The above-described property is conveyed subject to certain recorded and existing building restrictions, easements and rights-of-way.

The Grantee herein is to pay the 1959 taxes on the above-described property.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
