B. Compton and Katherine C. Compton, their heirs and assigns forever:**

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, in Paris Township, being known and designated as Lot No. 122, as shown on a Plat of Section No. 2, Bellwood Estates, dated 1955 by Woodward Engineering Company, recorded in the R. M. C. Office for Greenville County in Plat Book GG, at Page 50, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Bellwood Road, joint front corners of Lots 121 and 122 and running thence along the line of said lots, N. 51-25 W. 196 feet to iron pin; thence running with rear line of Lot 122, N. 37-35 E. 80 feet to iron pin rear corner of Lot 123; thence running with line of said lot, S. 51-25 E. 197.4 feet to iron pin on Bellwood Road; thence running with said Road, S. 37-35 W. 80 feet to iron pin at point of beginning.
