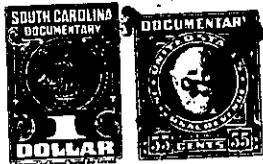

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Gertrude F. Ross, her heirs and assigns forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 37, as shown on a Plat of Section No. 1, Caroline Court, dated September 1953 by Dalton & Neves Engineers, recorded in the R. M. C. Office for Greenville County in Plat Book EE, at Page 44, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Marlana Avenue, joint front corners of Lots Nos. 36 and 37 and running thence along the line of said lots, S. 25-15 W. 247.3 feet to iron pin; thence running with rear line of Lot 37, S. 64-38 E. 100 feet to iron pin rear corner of Lot 38; thence running with line of said lot, N. 25-15 E. 247.5 feet to iron pin on Marlana Avenue; thence running with said Avenue, N. 64-45 W. 100 feet to iron pin at point of beginning.
