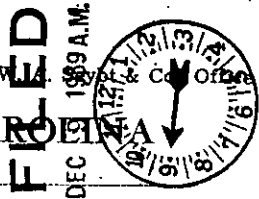

Know All Men by These Presents:

That I, M. W. Fore in consideration of the sum of Seven Hundred Eighty & NO/100 (\$780.00) - - - - - DOLLARS,

in the State aforesaid, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Orpha M. Dempsey, her heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, in Paris Township, being known and designated as Lot No. 72, as shown on a Plat of Section 2, Bellwood Estates, dated 1955 by Woodward Engineering Company, recorded in the R. M. C. Office for Greenville County in Plat Book GG, at Page 50, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Sunnydale Drive, joint front corners of Lots Nos. 72 and 73 and running thence along the line of said lots, N. 87-0 E. 150 feet to iron pin rear line of Lot 80; thence running with line of said lot N. 5-10 W. 147.7 feet to iron pin on South Silver Lake Drive; thence running with said Drive, S. 84-58 W. 120 feet to iron pin; thence running at a curve, 36.9 feet to iron pin; thence running with Sunnydale Drive, S. 3-00 E. 120 feet to iron pin at point of beginning.

NO residence shall be built on any lot costing less than Seven Thousand Five Hundred (\$7,500.00) Dollars; no residence shall be built on said lots nearer than twenty five (25) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS property is sold subject to the rights of way to Duke Power Company.
