in consideration of the sum of One Hundred, Fifty and No/100 (\$150.00) in the State aforesaid, and the assumption of mortgage set out below to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee, Wade H. Ridgeway, his heirs and assigns forever:

All that piece, parcel or lot of land, with the improvements thereon, situate, lying and being in or near Greenville, in the County of Greenville, South Carolina, and being more particularly described as Lot No. 375, Section 2, as shown on plat entitled "Subdivision for Abney Mills, Brandon Plant, Greenville, South Carolina", made by Dalton & Neves, Engineers, Greenville, S. C., February, 1959, and recorded in the Office of the R. M. C. for Greenville County in Plat Book QQ at pages 56 to 59. According to said plat the within described lot is also known as No. 21 Woodward Street and fronts thereon 100 feet; being the same conveyed to us by Abney Mills by its deed dated May 12, 1959, recorded in the R. M. C. office for Greenville County in Deed Vol. 627, at page 209.

The grantors hereby agree to deliver possession of the above premises to the grantee on or before January 15, 1960.
