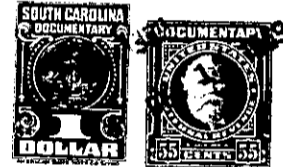
Know All Men by These Presents:

That I, Donald B. Norman, of Greenville County, in the State aforesaid, in consideration of the sum of (\$400.00) Four hundred and No/100 ----- DOLLARS, and assumption mortgage Independent Life & Accident Ins, Co., Jacksonville, Fla. to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Robert H. Chambers, his heirs and assigns forever:

ALL that lot of land in Greenville County, State of South Carolina, on the Northwest corner of South Washington Avenue and Texas Avenue, near the City Of Greenville, being a portion of Lot Nos. 8 and 9, Block P, as shown on a plat of Highlands, recorded in Plat Book K at Pages 50 and 51, and according to a recent survey made by J. C. Hill is described as follows:

BEGINNING at an iron pin at the Northwest corner of South Washington Avenue and Texas Avenue, and running thence with the Northern side of South Washington Avenue, N. 60-50 W. 127 feet to iron pin; thence N. 25-43 E. 126.6 feet to iron pin; thence S. 78-39 E. 68.3 feet to a nail and cap on Texas Avenue; thence with the Western side of Texas Avenue, S. 0-49 E. 154.6 feet to iron pin at the corner of South Washington Avenue; thence with the curve of the intersection, the chord is S. 58-54 W. 15 feet to the point of BEGINNING.

Being the same premises conveyed to J. C. Clark by deed recorded in Book Of Deeds 434 at Page 142.
