ALL that piece, parcel or lot of land in Cleveland Township, Greenville County, State of South Carolina, located on the South side of S. C. Highway No. 276 (Geer Highway), containing 0.84 acres, more or less, according to a plat made by J. C. Hill on May 16, 1953, and having, the following metes and bounds to-wit:

BEGINNING at an iron pin on the South side of Geer Highway at the intersection with a County Road, and running thence along said County road, S. 17-30 W., 175 feet to an iron pin; thence still along said County road, S. 25 W., 125 feet to an iron pin; thence N. 85 W. 118.7 feet to an iron pin on the Dunn line; thence along said line N. 18 E. 300 feet to an iron pin on the Geer Highway; thence along said highway, S. 83-15 E., 128 feet to the beginning corner.

AND ALL that piece, parcel or lot of land in School District 12 B, Greenville County, State of South Carolina, near Station No. 394 on State Highway No. 276, (the Geer Highway) between Marietta, S. C., and Cleveland, S. C., and being more particularly described, according to a plat prepared by W. K. Easley, in July, 1949, as having the following courses and distances, to-wit:

BEGINNING at a stake S. 18-W, 48 feet from the center line of S. C. Highway No. 276 (the Geer Highway), at Station 394 plus 26, and running thence N. 82 W. on a line 48 feet from and parallel to center line of said Highway 200 feet to an iron pin; thence S. 18 W., 98 feet to an 18 inch pine; thence on same bearing S. 18 W., 202 feet to a stake; thence S. 82 E., 200 feet to a stake; thence N. 18- E., 300 feet to the beginning corner.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and ~~her heirs and assigns forever~~ for and during her natural life.
