Know All Men by these Presents:

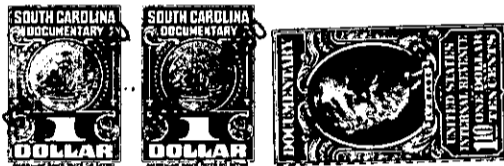
That Florrie V. Greer in the State aforesaid, in consideration of the sum of Nine Hundred and No/100 (\$900.00) DOLLARS,
