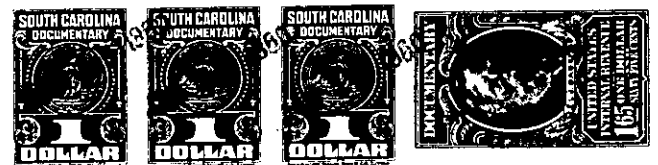
ODELL SHAVER, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, within the corporate limits of the City of Mauldin, and being known and designated as Lot Number 107 of a subdivision known as Glendale, a plat of which is of record in the R.M.C. Office for Greenville County in Plat Book QQ at Pages 76-77, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northeastern side of Paxton Avenue at the joint corner of Lots 106 and 107 and running thence N 49-46 E 175 feet to a point at the joint rear corner of Lots 106 and 107; thence N 40-14 W 140 feet to a point on the Southeastern side of Fairfield Drive at the joint corner of Lots 107 and 97; thence with the Southeastern side of Fairfield Drive S 49-46 W 150 feet to a point; thence following the curvature of the Southeastern intersection of Fairfield Drive with Paxton Avenue (the chord of which is S 04-46 W 35.3 feet) to a point; thence with the Northeastern side of Paxton Avenue S 40-14 E 115 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.

GRANTEE to pay 1960 taxes.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and His Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
