these presents do grant, bargain, sell and release unto the said

D. E. Galway, his heirs and assigns forever:

all that piece, parcel or lot of land in

Township, Greenville

County, State of South Carolina known as lot no. 9 on plat of Grand View of record  
in the R.M.C. Office for Greenville County in plat book KK at page 93 and  
having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Jasmine Drive, at the  
joint front corner of lots nos. 9 and 10 and running thence along the  
line of lot no. 10, N 17-25 W, 150 feet to an iron pin in the line of  
lot no. 24; thence along the line of lots nos. 24 and 25, S 72-35 W, 62  
feet to an iron pin at the rear corner of lot no. 8; thence along the  
line of lot no. 8, S 17-25 E, 150 feet to an iron pin on the northern  
side of Jasmine Drive; thence with said Drive N 72-35 E, 62 feet to the
