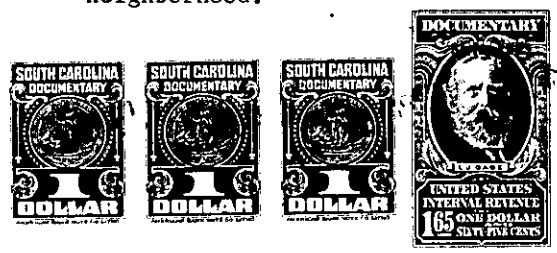
That W.E. McClain in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R.F. TUCKER, HIS HEIRS AND ASSIGNS:

All that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as a portion of the property of W.E. McClain according to a plat thereof, made by C.O. Riddle, Engineer, August 27, 1959, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of a right of way from White Horse Road; said iron pin being 150 feet in a westerly direction from White Horse Road and running thence N 28-23W 50 feet to an iron pin; thence S 76-22 W 56 feet to a point; thence in a southeasterly direction 60 feet, more or less, to a point on the said right of way; thence along said right of way N 66-22 62.1 feet to an iron pin at the point of beginning. This property is subject to the following restriction:
No obnoxious or offensive trade or activity shall be carried on upon any of the property, nor shall anything be done thereon which may be or become an annoyance or nuisance to the neighborhood.
