All that parcel or lot of land lying and being in the County of Greenville, State of South Carolina, being designated as Lots Nos. 17 and 46 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R. L. S., in January, 1959, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having, according to said plat, the following metes and bounds:

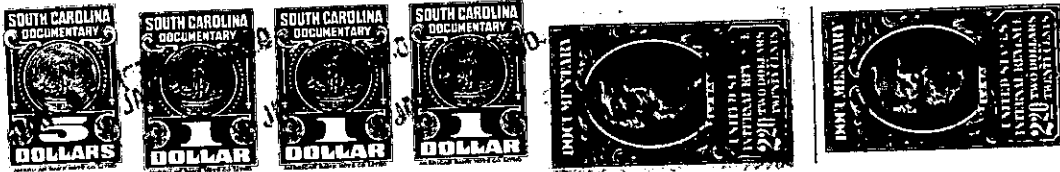
Lot No. 17 -

BEGINNING at an iron pin on the Northern side of Vicki Circle, the joint front corner of Lots Nos. 16 and 17, and running thence along the line of Lot No. 16 N. 4-31 E. 200 feet to an iron pin; thence S. 85-29 E. 100 feet to an iron pin; thence along the line of Lot No. 18 S. 4-31 W. 200 feet to an iron pin on the Northern side of Vicki Circle; thence with said side of Vicki Circle N. 85-29 W. 100 feet to an iron pin, the point of beginning.

Lot No. 46 -

BEGINNING at an iron pin on the Northern side of Roberta Drive, the joint front corner of Lots Nos. 45 and 46, and running thence along the line of Lot No. 45 N. 15-58 E. 188.7 feet to an iron pin; thence S. 77-58 E. 100.24 feet to an iron pin; thence along the line of Lot No. 47 S. 15-58 W. 195.8 feet to an iron pin on the Northern side of Roberta Drive; thence with said side of Roberta Drive N. 74-02 W. 100 feet to an iron pin, the point of beginning.

The foregoing lots are a portion of that conveyed to Wilkins Norwood & Company, Inc. by deed of Lucile L. Smith, et al, dated September 15, 1959, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Book 634 at page 188.
