to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ODELL SHAVER, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, within the corporate limits of the City of Mauldin, and being known and designated as Lot Number 112 of a subdivision known as Glendale, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book QQ at Pages 76-77, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southern side of Fairfield Drive at the joint front corner of Lots 111 and 112 and running thence S 09-21W 152.6 feet to a point at the joint rear corner of Lots 111 and 112; thence N 78-44 W 115.1 feet to a point at the joint rear corner of Lots 112 and 113; thence N 09-21 E 148.8 feet to a point on the Southern side of Fairfield Drive at the joint front corner of Lots 112 and 113; thence with the Southern side of Fairfield Drive S 80-39 E 115 feet to the point of beginning.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
