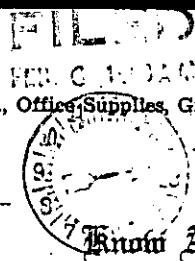

ALL of that lot of land in the Town of Simpsonville, County of Greenville, State of South Carolina being known as Lot No. 7 in Subdivision of E. J. Mullinax in accordance with plat made for E. J. Mullinax in accordance with plat made for E. J. Mullinax by C. O. Riddle dated May, 1958 and recorded in the R.M.C. Office for Greenville County in Plat Book 00 at page 153, and being more fully described in accordance with said plat, to-wit:
