to the grantor(s) in hand, paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. C. Balentine, his heirs and assigns forever:

ALL that certain piece, parcel and tract of land in Chick Springs Township, County and State aforesaid, known and designated as Lot No. Nine (9) on a plat of "Rosedale Sub-Division", prepared by C. O. Riddle, Registered Land Surveyor, in February, 1959, and recorded in the R.M.C. Office for Greenville County, said lot having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Rosemary Lane approximately 96.7 feet from it's intersection with Red Cherry Lane, at the joint front corners of lots Nine and Ten, and running thence N. 16-08 E. to an iron pin; Thence S. 73-52 E., 106.6 feet to an iron pin; thence S. 10-45 W., 155 feet along the joint lines of Lots Eight and Nine to an iron pin on the North side of Rosemary Lane; thence along said Rosemary Lane S. 76-34 E., 92.1 feet to the point of beginning, as appears on a Plat thereof in Book "MM", at Page 128.

The above described lot is conveyed subject to those certain Protective Covenants recorded in Book 632 at Page 135 in the R.M.C. Office for Greenville County, and in addition thereto is conveyed subject to a drainage easement on the Northeast side of said lot.
