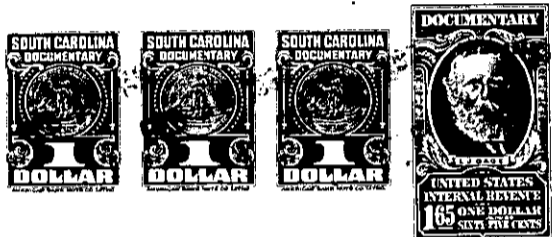

John F. West and Helga M. West, their Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina, and being known and designated as Lot No. 58 of Pecan Terrace, Section 2, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "EE", at Page 108 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of North Wingate Road at the joint front corner of Lots Nos. 58 and 59 and running thence along the joint line of said Lots, N. 19-23 W. 180.5 feet to a point at branch; thence along the branch as the line, the traverse line being N. 37-16 E. 108.9 feet to a point; thence along the joint line of Lots Nos. 57 and 58, S. 15-45 E. 242.8 feet to an iron pin on the northern side of said Road; thence along the northern side of said Road, S. 72-21 W. 63 feet to an iron pin; thence continuing along said Road, S. 70-37 W. 12 feet to the point of beginning.
