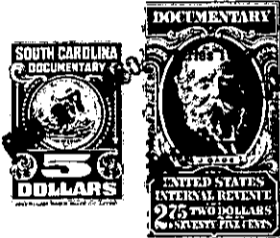

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Kenneth L. Holcombe, Jr., his heirs and assigns, forever:

all that piece, parcel or lot of land in Bates Township, Greenville County, State of South Carolina, having the following description:

BEGINNING on a stake in the road on the Poole line and running thence with said line N 59-00 W 233 feet to the Poole corner in the branch; thence down said branch as line S 66 W 173 feet to a bend in branch; thence S 38-30 W 82 feet to a bend in branch; thence S 23-00 W 100 feet to a corner in said branch; thence S 67-00 E 756 feet to an iron pin on the East side of the road; thence N 39-30 W 167 feet to an iron pin on the East side of the road; thence S 80-00 W 20 feet to the center of road; thence along the road as line N 45-00 W 141 feet to a bend in road; thence N 19-00 W 105 feet to a bend; thence N 05-00 E 90 feet to a stake in road on the Poole line, the point of beginning, containing 3.30 acres, more or less.
