All that piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina on the eastern side of Hunts Bridge Road at the southeast corner of Chickashaw Drive, known and designated as Lot No. 2 on a plat of Indian Hills, recorded in the R.M.C. Office for Greenville County in Plat Book QQ at Page 11 and having according to said plat the following metes and bounds to-wit:

BEGINNING at a point on the eastern side of Hunts Bridge Road, at the intersection of said road and Chickashaw Drive, and running thence S. 7-25 E. 110 feet, along Hunts Bridge Road, to a point; thence N. 82-45 E. 142.2 feet to a point; thence N. 8-25 W. 133 feet to a point on the southern side of Chickashaw Drive, thence S. 81-35 W., along Chickashaw Drive, 120 feet to a point; thence as the street curves to the left 28.5 feet (chord bearing S. 37.05 W.) to the point of beginning.
