TIMMONS, JR., in the State aforesaid, in consideration of the sum of One Thousand Seventy-Five and No/100-----(\$1,075.00)----- DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ODELL SHAVER, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, within the corporate limits of the City of Mauldin, and being known and designated as Lot Number 118 of a subdivision known as Glendale, a plat of which is of record in the R.M.C. Office for Greenville County in Plat Book QQat Pages 76-77, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northern side of Drury Lane at the joint front corner of Lots 117 and 118 and running thence N 11-16 E 170.9 feet to a point at the joint rear corner of Lots 117 and 118; thence S 78-44 E 145 feet to a point on the Western side of Rowan Street at the joint corner of Lots 109 and 118; thence with the Western side of Rowan Street S 11-16 W 145.9 feet to a point; thence following the curvature of the Northwestern intersection of Rowan Street with Drury Lane (the chord of which is S 56-16 W 35.3 feet) to a point; thence with the Northern side of Drury Lane N 78-44 W 120 feet to the point of beginning.
