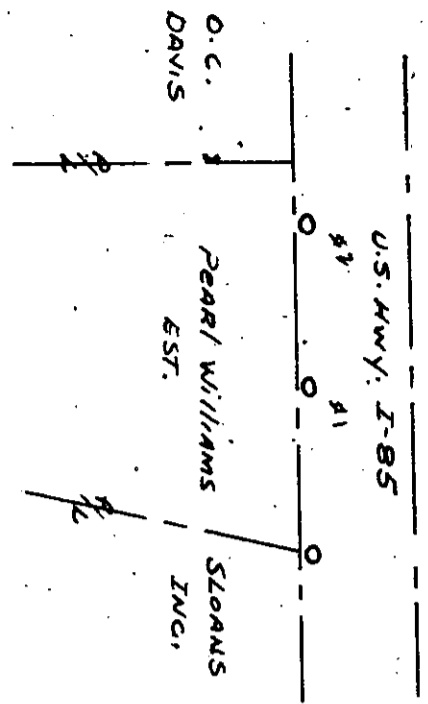

(INDIVIDUAL) Form 8416 Nov. '54

Received of the SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY ONE AND ----- No/100 Dollars in consideration of which (I) WE hereby grant said Company, its associated and allied companies, their respective licensees, successors and assigns, the right to construct, operate and maintain a line of communication consisting of such poles, wires, cables, conduits, guys, anchors and other necessary appurtenances as from time to time are required upon, across, over and/or under that certain tract of land situated in GREENVILLE County, State of SOUTH CAROLINA, to-wit:
THAT TRACT OF LAND BOUNDED ON THE EAST BY SLOANS INCORPORATED AND ON THE NORTH BY U.S. HIGHWAY I-85 AND ON THE WEST BY O.C. DAVIS.

and upon, along and under the roads, streets, or highways adjoining or through said property with the right to permit the attachment of and/or carry in conduit wires and cables of any other person or company for communications purposes or for the transmission and distribution of electric power and the right of ingress and egress to said premises at all times for the purpose of inspecting and maintaining said line and with the right to clear and keep cleared all trees, undergrowth or other obstructions within a strip of land (10) TEN feet on each side of the center of said line and to trim and cut and keep trimmed and cut all dead, weak, leaning or dangerous trees which might reach said line in falling; including the right to relocate said line on said premises to conform to any future highway relocation, widening or improvement; the said sum being received in full payment for the rights herein granted.

THE COMPANY AGREES TO RELOCATE AT ITS OWN EXPENSE, ON SAID PROPERTY, ITS LINES AND FIXTURES TO CONFORM WITH FUTURE BUILDING IMPROVEMENTS.
