to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

R. W. MANLEY, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 119 of a subdivision known as McSwain Gardens, Section 2, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book LL at Page 137, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southwestern side of Richbourg Road at the joint corner of Lots 118 and 119 and running thence S 67-00 W 141.7 feet to a point at the joint rear corner of Lots 118, 119 and 120; thence S 06-53 E 154.7 feet to a point on the Northern side of Old Spartanburg Road at the joint corner of Lots 119 and 120; thence with the Northern side of Old Spartanburg Road S 85-07 E 100 feet to a point; thence continuing with the Northern side of Old Spartanburg Road S 78-01 E 87.4 feet to a point; thence following the curvature of the Northwestern intersection of Richbourg Road with Old Spartanburg Road (the chord of which is N 39-29 E 27.7 feet) to a point; thence with the Southwestern side of Richbourg Road N 23-00 W 232.7 feet to the point of beginning.
