to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s)

Albert E. Campbell, his Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Highland Township, about one mile east of Mt. Lebanon Baptist Church, lying on the north side of the Mt. Lebanon Road, and being a part of Tract No. 1 as shown on Plat of Property of C. P. Williams made by H. S. Brockman, Surveyor, April 25th 1945, which was conveyed to me by C. P. Williams October 1st 1945 by deed recorded in the R. M. C. office for Greenville County in Deed Book 281 at page 82, and having the following courses and distances, to wit:-

Beginning on a nail and cap in the center of the said road, joint corner of Tracts Nos. 1 and 4, and runs thence with the Helen Fisher line, N. 62-05 W. 35.5 feet to a stake; thence continuing with the Helen Fisher line, N. 81-20 W. 158 feet to a stake on the said line; thence a new line, N. 46-15 E. 383 feet to a stake, joint corner of another lot being conveyed by me this day to Cora Mae Campbell; thence with the common line of the two lots S. 3-00 E. 254 feet to a nail and cap in the center of the said road (iron pin back on line at 20 feet); thence with the said road, S. 62-55 W. 114.6 feet to the beginning corner, containing One (1) acre, more or less.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining
