R.M.C Office for Greenville County, South Carolina.



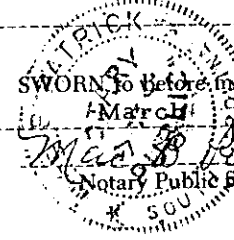
