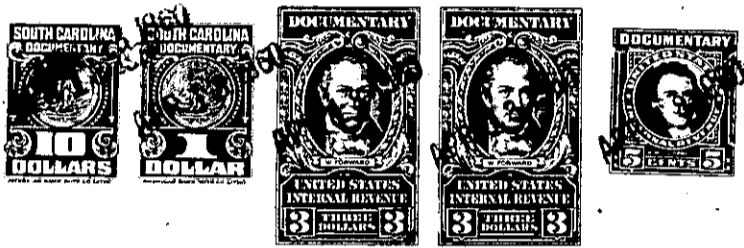
OLLIE EDITH USRY Know All Men by These Presents:

BEGINNING at a point on the south side of McCrary Street at the joint corners of Lots 1 and 2; thence S. 14-21 W. 72.3 feet along the line of Lot 2 to the rear corner thereof; thence N. 75-13 W. 70 feet along the rear line of said Lot 1 to Gridley Street; thence N. 14-21 E. 72 feet along said street to the front corner of Lot 1 on McCrary Street; thence S. 75-30 E. 70 feet along McCrary Street to the point of beginning.
