to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Minnie M. Stanley, her heirs and assigns forever.

All that lot of land with the improvements thereon, situate on the South side of East Washington Street, in the City of Greenville, In Greenville County, State of South Carolina, and having, according to a survey made by Dalton and Neves, Engineers, February 1928, the following metes and bounds.

BEGINNING at a point on the South side of East Washington Street, 1051 feet East from McDaniel Avenue, and running thence S 22-35 E 249.7 feet to a stake on C and WC right-of-way; Thence with said right-of-way N 46-47 E 94 feet to a stake; Thence N 27-10 W 219.5 feet to a stake on the South side of East Washington Street; Thence with the South side of East Washington Street S 69-15 W 72 feet to the beginning corner.

As part of the consideration of this conveyance, the grantee herein assumes and agrees to pay that Deed of Trust given by Minnie M.
