LOUIS COWARD CONSTRUCTION COMPANY, INC.:

All that parcel or lot of land lying and being in the County of Greenville, State of South Carolina, being designated as Lot No. 77 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R.L.S., in January, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Roberta Drive at the joint front corner of Lots Nos. 77 and 78, and running thence with the line of Lot No. 78 S. 15-19 W. 215.6 feet to an iron pin in the subdivision property line; thence with the subdivision property line S. 73-45 E. 89 feet to an iron pin in a water course at the joint rear corner of Lots Nos. 76 and 77; thence with said water course and the line of Lot No. 76 N. 28-58 E. 237.7 feet to an iron pin on the Southern side of Roberta Drive; thence with the Southern side of Roberta Drive N. 79-29 W. 146.2 feet to the point of beginning.

The foregoing lot is subject to a drainage easement along the water course as shown on said plat.

The foregoing lot is a portion of that conveyed to Wilkins Norwood & Company, Inc. by deed of Lucile L. Smith, et al, dated September 15, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 634 at page 188.
