OTT and FRANCIS J. OTT

All that parcel or lot of land lying and being in the County of Greenville, State of South Carolina, being designated as Lot No. 23 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R.L.S., in January, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Vicki Circle, the joint front corner of Lots Nos. 22 and 23, running thence along the line of Lot No. 22 N. 4-31 E. 200 feet to an iron pin; thence turning and running S. 85-29 E. 167 feet more or less to an iron pin at the rear corner of Lots Nos. 23 and 24; thence along the line of Lot No. 24 S. 27-10 W. 225.5 feet to an iron pin on the northern side of Vicki Circle; thence along the northern side of Vicki Circle N. 76-03 W. 53 feet to an iron pin; thence continuing with Vicki Circle N. 85-29 W. 27 feet to an iron pin, the point of beginning.
