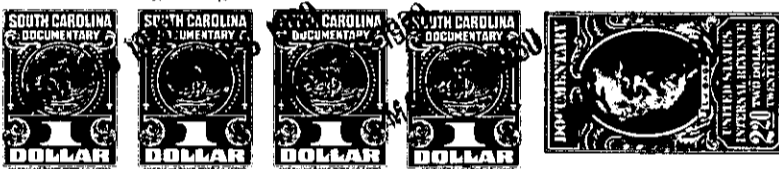

TIMMONS, JR., in the State aforesaid, in consideration of the sum of One Thousand Eight Hundred Seventy and No/100-----(\$1,870.00)--DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JESS B. KILPATRICK, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 85 of a sub-division known as McSwain Gardens, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Page 75; and having the following metes and bounds, to wit:

BEGINNING at a point on the Northern side of McSwain Drive at the joint front corner of Lots 84 and 85 and running thence N 27-50 W approximately 232.2 feet to a point in Brushy Creek, said point being the joint rear corner of Lots 84 and 85; thence with the center of said Brushy Creek as a line approximately N 63-29 E approximately 100 feet to a point, said point being the joint rear corner of Lots 85 and 86; thence S 27-50 E approximately 229.9 feet to a point on the Northern side of McSwain Drive at the joint front corner of Lots 85 and 86; thence with the Northern side of McSwain Drive S62-10 W 100 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.

GRANTEE to pay 1960 taxes.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and His Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
