Edgar W. Teasley, his heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being at the southerly corner of the intersection of Cool Brook Drive and Fleetwood Drive, near the City of Greenville, S. C., being shown as Lot No. 54 on the plat of Magnolia Acres as recorded in the RMC Office for Greenville County, S. C. in Plat Book GG, page 133, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Cool Brook Drive, which pin is the joint front corner of Lots 53 and 54, and running thence along the joint line of said lots S 36-57 W 163 feet to an iron pin, corner of Lots 54 and 55; thence with the joint line of Lots 54 and 55 N 22-27 W 179.9 feet to an iron pin on the southerly side of Fleetwood Drive; thence with the southerly side of Fleetwood Drive N 67-55 E 85 feet to an iron pin at the corner of the intersection of Fleetwood Drive and Cool Brook Drive; thence around said intersection on a curve, the chord of which is S 70-30 E 37 feet to an iron pin on the southwesterly side of Cool Brook Drive; thence with the southwesterly side of Cool Brook Drive S 41-40 E 60 feet to an iron pin; thence continuing with the southwesterly side of said Drive S 49-50 E 17 feet to the point of beginning.
