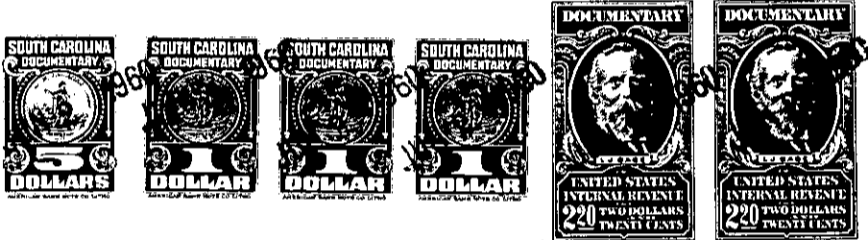
a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville, in the State of South Carolina
