Ann Curran B. Morgan, her heirs and assigns forever:

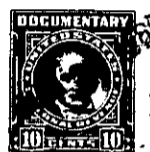
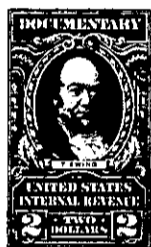
