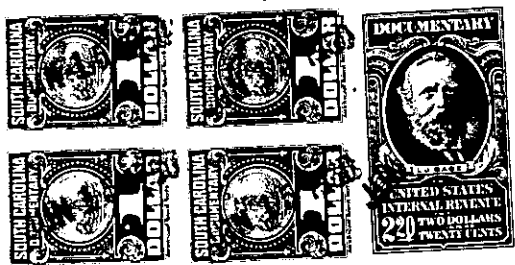
Know All Men by These Presents: 1960

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John K. Temple, Jr., his heirs and assigns,

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being Lot #67, White Horse Heights, which is recorded in Plat Book BB, page 182, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Easterly side of Range View Drive, joint front corner lots #66 and #67, and running thence N 48-52E 175 feet to an iron pin, joint rear corner lots #66 and #67; thence S 41-08 E 85 feet to an iron pin, joint rear corner lots #67 and #68; thence S 48-52 W 175 feet to an iron pin on Range View Drive, thence N 41-08 W 85 feet to an iron pin, the point of beginning.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
