TIMMONS, JR., in the State aforesaid, in consideration of the sum of TWO THOUSAND FIVE HUNDRED FIFTY AND NO/100 DOLLARS, (\$2,550.00) to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ROBERT F. PARKS, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 68 of a subdivision known as McSwain Gardens, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Page 75, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southwestern side of Shannon Drive at the joint front corner of Lots 67 and 68 and running thence S 53-53 W 192 feet to a point at the joint rear corner of Lots 67 and 68; thence with the rear line of Lot 68 N 02-55 W approximately 28.4 feet to a point in a branch; thence with said branch as a line approximately N 38-30 W approximately 52.7 feet to a point, the joint rear corner of Lots 68 and 69; thence with the joint line of Lots 68 and 69 N 40-41 E 156 feet to a point on the Southwestern side of Shannon Drive at the joint front corner of Lots 68 and 69; thence with the Southwestern side of Shannon Drive S 49-19 E 115 feet to the point of beginning.
