That I, WILLIAM R. TIMMONS, JR., in consideration of the sum of ONE THOUSAND NINE HUNDRED FORTY-FIVE AND NO/100---- DOLLARS, (\$1,945.00) to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. LEWIS STOVER, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 4 of a subdivision known as McSwain Gardens, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Page 75, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Mimosa Drive at the joint front corner of Lots 3 and 4 and running thence S 25-41 E 176.6 feet to a point at the joint rear corner of Lots 3 and 4; thence S 64-19 W 91.5 feet to a point at the joint rear corner of Lots 4 and 5; thence N 25-41 W 175 feet to a point on the Southeastern side of Mimosa Drive at the joint front corner of Lots 4 and 5; thence with the Southeastern side of Mimosa Drive N 64-19 E 71.3 feet to a point; thence continuing with the Southeastern side of Mimosa Drive N 60-04 E 20.4 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.
