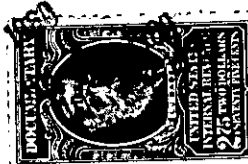

That Albert T. Vaughan, Jr. in the State aforesaid, in consideration of the sum of Two Thousand Four Hundred and No/100 DOLLARS, and assumption of mortgage described below, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ALICE EZELLE McLURE, her heirs and assigns:

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 11, Plat of Property of Furman C. Smith and G. Herman Walker, as per plat thereof, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book S, page 3, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Northwood Avenue at joint front corner of Lots 9 and 11, and running thence with the line of Lot No. 9, N. 1-26 E. 168.1 feet to an iron pin; thence S. 87-14 E. 29.2 feet to an iron pin; thence S. 56-04 E. 47.3 feet to an iron pin at rear corner of Lot No. 13; thence with line of Lot No. 13, S. 1-26 W. 141 feet to an iron pin on the northerly side of Northwood Avenue; thence with the northerly side of Northwood Avenue, N. 87-34 W. 70 feet to the beginning corner.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to C. Douglas Wilson & Co. on which there is a balance due of \$ 8105.02, said mortgage being recorded in the RMC Office for Greenville County, South Carolina, in Mortgages Volume 604, page 377.
