That CALVIN S. MOORE in the State aforesaid, in consideration of the sum of ONE THOUSAND TWO HUNDRED FIFTY AND NO/100-----DOLLARS, and assumption of mortgage described below, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Loyall H. Smith, his heirs and assigns,

All that piece, parcel or lot of land lying and being on the Easterly side of Linnet Street (formerly Link Street) at the Northeasterly corner of the intersection of Linnet Street and Loganberry Circle (formerly Elm Drive), near the City of Greenville, South Carolina, in the County of Greenville, State of South Carolina, being shown as part of Lots Nos. 8, 9, and 10 on the plat of the subdivision of T. T. Link, as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book D, page 248, and having, according to a plat made by R. W. Dalton, June 30, 1950 (not recorded), the following metes and bounds, to wit:

BEGINNING at an iron pin at the Northeast corner of the intersection of Linnet Street (formerly Link Street) and Loganberry Circle (formerly Elm Drive) and thence along the Easterly side of Linnet Street N. 6-38 E. 78.6 feet to an iron pin on the Line of Lot No. 10; thence along the line through Lots Nos. 8, 9, and 10 S. 83-22 E. 166 feet to an iron pin in Lot No. 8; thence along a line through Lot No. 8 S. 6-38 W. 78.6 feet to an iron pin on the Northerly side of Loganberry Circle; thence along the Northerly side of Loganberry Circle N. 83-22 W. 166 feet to the point of beginning.

As a part of the consideration hereof, the Grantee agrees to assume and pay, according to its terms certain note and mortgage given to Goodyear Mortgage Corporation, which mortgage is recorded in Mortgages Volume 529, page 395.
