KNOW ALL MEN BY THESE PRESENTS That We, Catharine Gosnell McMillin and Pearl McMillin Neves

in the State aforesaid, in consideration of the sum of Four Thousand & No/100 Dollars

to us in hand paid at and before the sealing of these presents by C. S. West

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. S. West

all that piece, parcel or lot of land in Highland Township, Greenville County, State of South Carolina, described as follows:

Land situated and lying and being on East side of road leading from Gownsville to Greer, adjoining lands of S.G. Wingo, J.O. Weaver, R.L. McMillin and M.M. McMillin.  
\* Beginning on an iron pin in old road on S.G. Wingo's line; thence North 84.38 West 37 links to an iron pin in center of new road, and in S.G. Wingo's line; thence with new road North 35 East 3.68 chains to turn; thence North 10 1/2 East 1.85 to turn thence North 27 West 9.40 to turn; thence North 3 1/2 West 1.29 to an iron pin in center of road, and in Weaver's line; thence with Weaver's line North 75 East 20.50 to stone; thence South 57.3 8' West 19.21 with McMillian's line to an iron pin in old road; thence with said old road South 50 East 3.28 to turn thence South 19 East 1.63 to turn; thence S. 35 West 7.12 to beginning containing Seven and 85/100 acres more or less.

Also, all that certain lot or parcel of land situated lying and being in state and county aforesaid on East side of road leading from Gownsville by S.G. & J. O. Wingo's, adjoining lands of S.G. Wingo, William McMillin, Jr. and J.H. Atkins beginning at an iron pin in or near road on S.G. Wingo's line. Thence North 35 East 7.12 with road, thence with road North 19 West 1.63 thence with road North 50 West 3.28 to iron pin; thence North 57-38 East 19.21 to stone on Skinner's line thence; North 75 East 92 links to stone on J.H. Atkins line thence South 2-6 West 21-68 white oak stump; thence North 84-38 West 17.50 in beginning containing 25 17/100 acres more or less.
