All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, Gantt Township, County of Greenville, State of South Carolina, and having according to a plat prepared by C. O. Riddle, R.L.S., dated March 26, 1959, entitled "Property of Otis Davis," the following metes and bounds:

BEGINNING at an iron pin at the Southwestern corner of the intersection of Prosperity Avenue (formerly Plantation Road) and Theresa Drive and running thence with the Southwestern side of Prosperity Avenue and following the curve thereof, the chord of which is N. 52-21 W. , 188.6 feet to an iron pin; thence S. 20-55 W. 203.7 feet to an iron pin at the joint rear corner of the lot herein conveyed and a lot conveyed this date to Preston Posley, et al., thence with said Posley property S. 56-50 E. 175.5 feet to an iron pin on the Northwestern side of Theresa Drive; thence with the Northwestern side of Theresa Drive N. 23-43 E. 186.8 feet to the point of beginning.
