All that lot of land in the County of Greenville, State of South Carolina, being shown as the Brooks lot on plat of property of Daisy B. Cleveland Estate made by J. C. Hill, August 28, 1959, and recorded in the R. M. C. Office for Greenville County in plat book 00 at page 410 and being a portion of tract No. 5 as shown on plat of J. Norwood and R. Mays Cleveland made by Dalton & Neeves dated June, 1927, and having, according to the first mentioned plat, the following metes and bounds, to-wit:
